Lancang-Mekong Inspector Training Program

Goal

The course provides aviation safety inspectors at the beginner's level with the competencies required to conduct specific safety oversight functions in accordance with ICAO's Standards and Recommended Practices (SARPs), and technical guidance.

Learning Objectives

After having successfully completed the course, participants will be able to:

- Establish and maintain a basic understanding of supervision and oversight;
- Obtain knowledge to conduct regulatory oversight;
- Manage an oversight inspection by demonstration;
- Determine the effective methods of oversight;
- Administer, evaluate, and document the results of oversight inspection;

Modules	Module Descriptions
Principles of Oversight	With reference to ICAO's Doc.9734, using China's state safety programme of civil aviation oversight as example, this module introduces the common oversight principles and demonstrates how to conduct oversight with the latest techniques.
Concept of Safety Management	With reference to ICAO's Annex 19 and Doc. 9859, this module enable the participants with the concept and methodologies of safety management in different areas and scenarios.
Career Development of CASIs	With reference to ICAO's Doc. 9868/ Doc.10070, this module demonstrates an clear career path for the CASIs throughout their professional life
Industrial Overview	Based on the case study of representative entities ranging from airline, airport to manufacturer, this module enables the participants to have an insightful perception of the development of civil aviation industry
Practical Operation	With realistic, but hypothetical, scenario-based exercises, this module help the participants to be familiar with the future work scenarios and demonstrate the knowledge and skills required to perform one or a combination of the oversight duties and tasks.
